2016-2017 Application

GOALS – Through the creation of a climate of love and understanding and a rich variety of experiences in a physical and social environment favorable to the development of children, each child will be helped to grow physically, emotionally, socially, intellectually, and spiritually. Through freedom in a structured environment the child will be encouraged to explore, experiment, create, pretend and discover at his/her own pace. Teachers will concentrate on individual growth and development as well as group learning experiences.

PROGRAM – Elizabethtown Community Nursery School (ECNS) is accredited by the National Association for the Education of Young Children (NAEYC) – a widely recognized mark of high quality. Also licensed by the State Board of Private Academic Schools, all teachers are state certified in Early Childhood.

Classes run for thirty weeks beginning mid-September and ending in May. Each 4 and 5-year-old class will have sixteen children and two adults, while each three-year-old class will be limited to fourteen children with two adults. Children need to be three, four or five years old on or before September 1 following EASD's age criteria.

ECNS admits students of any race, color, national and ethnic origin to all the rights, privileges, programs, and activities generally accorded or made available to students at the school. It does not discriminate on the basis of race, color, national and ethnic origin in administration of its educational policies, admissions policies, financial aid and other school-administered programs.

OPEN HOUSE – You are invited to our Open House to be held Monday, Tuesday and Wednesday, February 8, 9 and 10 from 9:30 AM - 1:30 PM. One of our Board or staff members will be on hand to show you our facilities and answer questions. You may park behind the church, enter the educational wing (flat roof), and go down the steps to our classrooms.

REGISTRATION – ECNS will have early registration beginning February 8, 2016, for children presently enrolled in one of our classes. General registration for all other children will begin February 15. Applications returned early will be dated the first day of the **early** or **general** registration. Please submit the application and information sheet with the \$50.00 non-refundable registration fee to ECNS, 777 S. Mt. Joy Street, Elizabethtown, PA 17022. If you have more than one child in the program, the registration fee for each additional child is \$25.00. Letters of acceptance will be mailed mid-March; other information including teacher and room assignments will be mailed early August. Teachers will make home visits by appointment, and there will be an Open House prior to the first day of school.

2016-2017 TUITION - Tuition for the year is divided into nine equal payments. The first payment is due August 16, with remaining payments due the first of each month, October through May. *Payments not received or postmarked by the due date will incur a 10% late fee.* Because of budgetary requirements, no adjustment can be made in tuition for absence due to illness, prolonged out-of-town visits, etc. *If withdrawal is necessary, we request a two-week notice.*
